When I began my term as President I planned three main goals: to improve IPSO's inreach as an organization for candidates, which includes sharing our news with IPA members, to collaborate in Psychoanalysis Outreach and to improve IPSO's working organization (reviewing procedures, bylaws and its internal functioning within the Executive Committee).

We improved our website, included Facebook as a worthy tool to keep candidates closer, and we are exchanging our newsletter with IPA members.

We included all of the Visiting Candidate Program (VCP) reports in our website. The VCP shows exactly what the IPSO spirit is about, international participation and exchange.

Being aware of the high cost of traveling, especially for some candidates leaving in certain countries, we started to develop virtual conferences among different regions with very good results, encouraging and making candidates become "attracted" by the IPSO spirit! I hope you enjoy this "trip" around the world, reading all the different regional activities.

Soon we'll be enjoying Prague Congress, a Congress that has been especially designed to fulfill candidates' expectations.

Europe

In August, the 22nd IPSO and 48th IPA Congress are going to take place in the old continent, in Prague/Czech Republic and we are all very busy with the preparations for this event. In spite of this forthcoming very distinguished and important event the other events and meetings in Europe during the first half of this year have been very well attended by analysts in training. There is a very remarkable and promising development of an increasing number of IPSO members and colleagues in Europe who organize with great commitment IPSO activities of different sorts and kinds like the IPSO Study Day, the IPSO European meeting and special IPSO events during several psychoanalytical congresses and meetings throughout Europe. These are excellent opportunities to bring together analysts in training and senior analysts from different regions, continents and psychoanalytical backgrounds. We would like to thank our IPSO colleagues who do organize so many interesting events in connection with IPSO for their commitment to the IPSO idea!

We hope we can interest you in what IPSO can offer by informing you about IPSO activities in Europe in the last six months and forthcoming events in the second half of this year.

Past Events

IPSO Study Day in Frankfurt/Main, Germany, February 09-10, 2013 Title: "Understanding the Scene": Szenisches Verstehen (Scenic Understanding), about a concept of psychoanalyst and patient performing together.

This event was organized by colleagues and IPSO members from the Frankfurt Psychoanalytic Institute. Psychoanalytic reasoning is flourishing in Frankfurt and is developed and studied here in unison and cooperation with the local Institute of Psychoanalysis. Focus of the meeting was the concept of "Szenisches Verstehen" (Understanding the Scene) elaborated simultaneously by the psychoanalysts Alfred Lorenzer and Hermann Argelander from Frankfurt in 1970. This concept is a basic one in the German psychoanalytic thinking. Thanks to the great efforts of the local organizers Inga Friedrich, Ewa Leban, Sarah Römisch and Katrin Schwind, 67 participants from 14 countries (Germany, Netherlands, Switzerland, Spain, Italy, Austria, Czech Republic, France, Russia, Ukraine, Armenia, Norway, Israel and Serbia) could take part in lectures and workshops by training analysts of the Frankfurt Psychoanalytic Institute (DPV): Werner Bohleber, Tomas Plänkers and Rotraut de Clerck. Werner Bohleber spoke about the evolution of psychoanalytic thinking in Germany from the origins of psychoanalysis to the 1970's when Lorenzer and Argelander independently theorized the concept of "Szenisches Verstehen". In those years, Frankfurt became the cradle of hermeneutic philosophy - or the art of interpretation - reaching its apex in Gadamer's "Truth and Method" (1960). All this was of great impact in the German cultural and scientific debate in which

psychoanalytic thinking developed during those years. Werner Bohleber concentrated mainly on Argelander's work, to show how in this author's view the "Scene" constitutes a way of communication in itself, and how it contributes with its own value besides the conscious and unconscious communications of Argelander's both patient and analyst. "Szenisches Verstehen" (1970), becomes the Gestaltian background providing the structure that confers meaning to the communications, as the scene unconsciously reproduces constellations of childhood conflicts of the patient on which the transference develops. In following years other theorizations on the meaning of enactment or intersubjectivity contributed to clear the concept of "Szenisches Verstehen". Tomas Plänkers discussed in his lecture "Understanding the psychoanalytic Scene and the Kleinian view of transference", the conceptual changes that Melanie Klein had brought to Freud's classic theory regarding the relationship between patient and analyst. He presented an interesting clinical vignette to highlight the Kleinian concepts in the clinical material and referred to Argelanger and Lorenzer. The first in relation to the concept for which the patient's ego is responsible for the internal analytic scene, the second being closer to the relational perspective. Rotraut De Clerck presented her work on "Scenic Understanding in Art and Literature". In this case too, the concept of "Szenisches Verstehen" was explored and defined as a complex structure of conscious, unconscious, and pre-conscious elements that bring together different levels of understanding: perception, (fantasy), phantasies, transferential imagination and counter-transferential feelings. De Clerck thus showed how these concepts can be applied to interpretations of art, commenting Georges Perec's, "La Disparition" (1969), a book written entirely by omitting the letter 'e'. She described very touchingly the scenes that could have led the author to write this book. Finally, De Clerck distinguished the concept of transference and countertransference relationships from the concept of "Szenisches Verstehen". The first one concerns the internal object relations and its correlated phantasies, the second one offers a double perspective focused on unconscious emotional experiences on one side and the world outside and the external context on the other.

During the afternoon Werner Bohleber, Tomas Plänkers, Rotraut De Clerck and Maria-Elisabeth Eckardt – another training analyst from Frankfurt - worked together with the candidates in clinical groups. Clinical cases were presented and the groups focused on the concept and relevance of "Szenisches Verstehen". These supervision groups were characterized by a free and meaningful exchange amongst candidates in a nonjudgmental and friendly environment. The result of what was discussed in the supervision groups was then presented in the final plenary session.

The day ended in a typical Frankfurt restaurant where we danced, socialized and exchanged ideas on our psychoanalytic Bahcesehir University, Besiktas Campus, Istanbul/Turkey, training as well as on our view of psychoanalysis today. All in full May 31-June 1 2013 Topic: HOMOSEXUALITIES IPSO spirit! On Sunday, a guided tour through the city of Frankfurt and a visit to the Museum of Modern Arts Frankfurt (MMK) was organized to close the weekend.

IPSO Program at the 26th EPF Annual Conference in Basel, Switzerland, March 20-24, 2013. Title: 'Formlessness: Deformation, Transformation'

In Basel, we were warmly welcomed by our colleagues. The local organization committee did its best to provide us with an excellent week with entertaining scientific and social events. Just as the year before, we offered IPSO workshops with the 'Listening to Listening' discussion method by Haydee Faimberg from Paris which were moderated by her and also by Dieter Bürgin, a training analyst from Basel. Besides these four workshops on Listening to Listening in French and English, we had four supervision groups during the EPF Conference. We had supervisors from Russia, the Netherlands, Finland and Switzerland and analysts in training from the Czech Republic, Russia, Belgium and Israel presenting their cases and making possible to get to know the psychoanalytic work and way of thinking of analysts and analysts in training from a great variety of different European countries and languages. In the opening plenary of the IPSO program Manuel Horlacher from Basel presented his paper with the title "Repression shapes". Although his paper was founded in theory, a lively discussion emerged in the audience after his presentation. On the Friday evening we had a great and enjoyable IPSO party, where the winner of the European Raffle for the IPA-IPSO Congress was chosen. Manuela Martelli from Italy was the lucky winner of a free registration for the IPA-IPSO Congress in Prague.



73rd Congress of the French Speaking Psychoanalysts (73e Congrès des Psychanalystes de Langue Française, CPLF), Paris, France, May 9-12, 2013, Topic: 'Le Paternel'

The IPSO group of the Istanbul Psychoanalytical Association organized an IPSO day with paper presentations on different aspects of homosexualities in the psychoanalytical theory and practice. As the Vice President-elect for Europe, Anna Mária Hansjürgens had the possibility to talk about IPSO in the opening session. As you might have read in the newspapers, these days have been difficult in Istanbul and Turkey in general.

On the first day just before the congress started a fellow candidate of ours Burcin Alsancak-Sonmez was buried. She was a young and gifted psychologist who had been ill for many years. In spite of this tragic event our colleagues gave us a special welcoming atmosphere and very interesting paper presentations. We were invited to a dinner party at the Fenerbachce Sailing Club where our colleagues from Istanbul showed us the "tastes of their culture". The candidates of the Istanbul Psychoanalytical Society were also very active during the COWAP congress, with lectures and case presentations. On Saturday noon the Bahcesehir University who had hosted the congress was evacuated. The peaceful protest in the city went on and our Turkish colleagues did everything to secure our way home. On Sunday, Anna was invited by Aysenur Aytekin at her home to discuss the future programs. Anna was told before about how the Turkish welcome their guests but she was surprised and impressed about their affection and care. In Anna Maria's words "I would like to thank my Turkish colleagues again and send my sympathy to the psychoanalysts in Istanbul who are living a much tormented time now".

22nd IPSO Congress (in connection with the 48th IPA Congress), Prague, Czech Republic July 30 - August 3, 2013 Topic: 'Facing the Pain: Clinical Experience and the Development of Psychoanalytic Knowledge'

The next IPSO/IPA-Congress will take place in Prague/Czech Republic. With the main topic: 'Facing the Pain: Clinical Experience and the Development of Psychoanalytic Knowledge' this congress will offer a wide range of topics, but mainly aims to explore how analysts and patients face psychic pain in the clinical experience and how these encounters inform the ways we develop psychoanalytic theory and technique. Three major topics will be addressed during the congress: depression, disturbances of affect regulation and disruptions in the process of symbolization. The IPSO congress program begins on Tuesday, July 30th in the morning with a plenary session and with the IPSO Forum in the afternoon. The IPSO program will also include paper presentations, supervisions, Meet-the-Analyst sessions, peer

IPSO clinical discussion group, American Psychoanalytic Association (APsaA) Winter Meeting, New York, U.S.A., 14-18 January 2013.

This clinical discussion group opens, officially, every year the activities from the North American region. This year Graciela Hoyos, IPSO Editor from Colombia presented the clinical material which was commented by Aura Lorenzo (Latin America's Vice President-Elect, Mexico), Holger Himmmighoffen (Europe's Vice President, Switzerland) and Michael Garfunkel (analyst in training from New York Psychoanalytic Institute). Deisy Boscan (North America's Vice President, San Diego), chaired the discussion.



Clinical Working Parties, New York U.S.A., 1-2 March 2013

On March 1and 2nd, 2013, Marco Posadas had the opportunity to attend the Clinical Working Party on the "Specificity of Psychoanalytic Treatment Today" to continue building a relationship with that working party committee and actively participate as a candidate. We hope to build a collaborative relationship with the working parties committees of the IPA to expand the possibilities for candidates to participate in these amazing learning opportunities in the future. This working party happened at the New York Psychoanalytic Society and Institute and organized in collaboration with IPSO to make these working parties available for candidates.

There were also 2 spots available for candidates per working party in addition to the working party targeted to candidates. The candidates were well received, and it was inspiring to see how well we shared the same struggles and passion for the analytic process. Treatment Today is a research method based on an analogical relation between the analytic sessions and their narration. The Working Party has found that owing to the associative thinking of analysts working together, the clinical research group functions as a magnifying echo of the transference-countertransference relation between patient and analyst. We would like to thank Drs. Bill Glover and Margaret Ann FitzPatrick-Hanly for their support in providing spaces for candidates in the working parties and to Drs. Ronnie Shaw and Philippe Valon for their actively involvement and for making sure that candidates participate in these events. Please stay tuned for more information regarding clinical working parties that will be happening in North America and Latin America in 2014.

On 8th – 9th March 2013, IPSO presented its 3rd North American Conference. Entitled "Journeys in Psychoanalysis: The Clinical Experience on Three Continents," the conference was held at the School of Medicine, University of California, San Diego (UCSD), on the campus located in La Jolla, California.

Deisy C. Boscan, PhD, IPSO Vice President for North America who served as conference chair, initiated the conference recognizing that while psychoanalysis was developed in Vienna and London in the late 19th and early 20th Centuries by Sigmund Freud as an outgrowth of social issues impacting life in Europe at the time, as the field has matured and grew, not only in Europe but also, in North and South America, the three continents are quite active in the field today. Local culture and traditions have defined and molded the treatment approaches in each of those geographic regions. The aim of the conference was to discuss that aside from learning the science and art of the field, it is important for candidates to understand how the practice varies as the result of many sociological conditions, including geography and life conditions, and to better grasp the impact of those variances. Finally, the Conference, being held for the first time in San Diego, enabled candidates as well as some practicing analysts in the western US states and western Canadian provinces to glimpse the wider aspects of the field and to develop a closer tie with other colleagues from other places.

The discussants commented on four outstanding case studies presented by IPSO candidates: Dr. Carlos Almeida from New York City; Dr. Cuneyt Iscan from Boston; Dr. Holly Johnston from Chicago; and Dr. Barbara Mosbacher, from Houston.
